The proxy form shall be delivered to the company's Securities agent at the Transfer Agency department of Yuanta Securities at least 5 days prior to the meeting so that the registration card can be issued to the proxy.

If shareholders intend to solicit proxy forms, the company is required to compile details on the proxy solicitation parties and disclose such information on the website of the Securities and Futures Institute (SFI) on May 19th, 2022. Shareholders can inquire information on proxy solicitation firms from the free proxy disclosure& related information system" (<u>https://free.sfi.org.tw</u>).
