The proxy form shall be delivered to the company's Securities agent at the Transfer Agency department of Yuanta Securities at least 5 days prior to the meeting so that the registration card can be issued to the proxy.



6. The statistical verification institution of the proxy form for the Meeting is Transfer Agency Department of Yuanta Securities.

If shareholders intend to solicit proxy forms, the company is required to compile details on the proxy solicitation parties and disclose such information on the website of the Securities and Futures Institute (SFI) on May 19<sup>th</sup>, 2022. Shareholders can inquire information on proxy solicitation firms from the free proxy disclosure& related information system” (<https://free.sfi.org.tw>).

The main contents of this meeting including the provisions of Company Act article 172, except for specified in the convening notice, please refer to TWSE’s Market Observation Post System website (<http://mops.twse.com.tw>) for searching electronic books, annual report and relevant materials illustrated major items proposed in the meeting.
9. The voting right of shareholders can be exercised electronically in this shareholders' meeting. The period of exercise shall be as follows: from May 22<sup>nd</sup> 2022 to June 18<sup>th</sup> 2022.
